

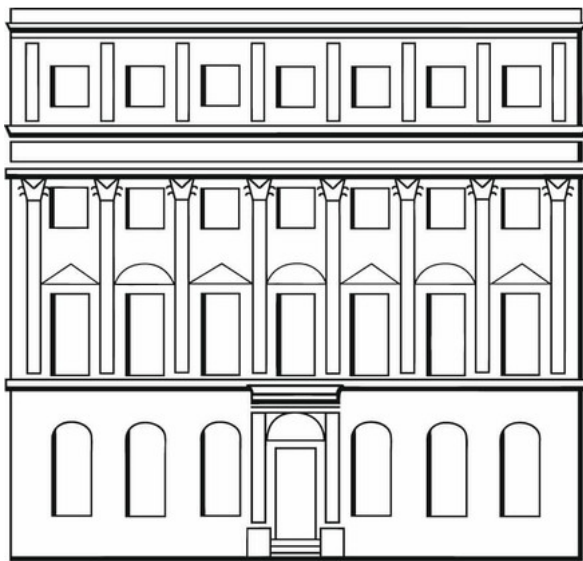

Notes on Contributors

JOËLLE DROUX is a Senior Lecturer in History of Education in the Faculty of Psychology and Educational Sciences at the University of Geneva, where she received her Ph.D. in 2001. She is working on the history of international child welfare movements; social and humanitarian networks during the twentieth century; and the long-term evolution of Swiss child and youth welfare policies. Her publications include: co-edited with Sandrine Kott, *Globalizing Social Rights: The International Labour Organization and Beyond* (Basingstoke, 2013); and co-edited with Rita Hofstetter, *Globalisation des mondes de l'éducation: Circulations, connexions, réfractions (19e–20e siècles)* (Rennes, 2015).

HEIDE FEHRENBACH is Board of Trustees Professor and Distinguished Research Professor of History at Northern Illinois University. After receiving her Ph.D. at Rutgers University in 1990, she held tenured positions at Colgate University and Emory University. Her research has been supported by fellowships from the John Simon Guggenheim Memorial Foundation, the American Academy in Berlin, the American Council of Learned Societies, and the National Endowment for the Humanities. Her books include: *Cinema in Democratizing Germany: Reconstructing National Identity after Hitler* (Chapel Hill, NC, 1995); *Race after Hitler: Black Occupation Children in Postwar Germany and America* (Princeton, 2005); and with Rita Chin, Geoff Eley, and Atina Grossmann, *After the Nazi Racial State: Difference and Democracy in Germany and Europe* (Ann Arbor, 2009); and she is co-editor, with Davide Rodogno, of *Humanitarian Photography: A History* (New York, 2015). She is currently at work on a history of child-centred humanitarian imagery since the nineteenth century.

MICHAL GIVONI is a Lecturer in the Department of Politics and Government at Ben Gurion University of the Negev. She completed her Ph.D. at the Cohn Institute for the History and Philosophy of Science and Ideas at Tel Aviv University in 2008. She was a postdoctoral fellow in the Department of Sociology and Anthropology at Tel Aviv University, the Minerva Humanities Center at Tel Aviv University, and Fulbright Fellow at the University of California, Berkeley. She was also a researcher at the Van Leer Jerusalem Institute, where she co-directed a project on the Israeli occupation in the Palestinian territories. Her book, *The Ethics of Witnessing: A History of a Problem*, was published in Hebrew by the Van Leer Institute/Hakibutz Hame'uchad.

ALAIN GUILLOUX is a Visiting Assistant Professor in the Department of Asian and International Studies, City University of Hong Kong. He received his Ph.D. in 2007 at the University of Hong Kong. A former executive and board member of Médecins sans Frontières, he has over twenty years of experience in humanitarian action, development assistance, and non-profit management. His research interests include humanitarian action, disaster risk governance, and development aid, in particular in the Asian context. He is the author of 'Regional Governance and Disaster Response', in Nicholas Thomas (ed.), *Governance and Regionalism in Asia* (London, 2009); and *Taiwan, Humanitarianism and Global Governance* (London, 2009).

FLORIAN HANNIG is a Ph.D. student at the University of Halle-Wittenberg and a former member of the international graduate school 'Formenwandel der Bürgergesellschaft', Halle-Tokyo. He is writing his Ph.D. thesis on the emergence of an international humanitarian aid regime in the 1960s and 1970s. His research interests encompass human rights after the Second World War and international history.

IRÈNE HERRMANN is Associate Professor of Transnational Swiss History at the University of Geneva. She received her Ph.D. at Geneva in 1997 and taught at Université de Laval in Québec and at the Russian University for the Humanities in Moscow. Her research interests include the contemporary history of Switzerland; the history of post-Soviet Russia; and the uses of the past. She is co-editor of *Parler de soi sous Staline: la construction identitaire dans le communisme des années trente* (Paris, 2002), and her other publications include *Les Cicatrices du passé: essai sur la gestion des conflits en Suisse, 1798–1918* (Berne, 2006); and 'From Polemical Topics to Magnetic Concepts: Humanitarianism and Anti-Semitism in Switzerland', *Journal of Political Ideologies*, 15/1 (2010).

YOUNG-SUN HONG is Professor of History at the State University of New York, Stony Brook. In recent years she has been a Fellow at the Harvard University Center for European Studies and the Woodrow Wilson International Center for Scholars in Washington, DC. She has received several fellowships from major organizations, including the German Marshall Fund, the SSRC, and the German Academic Exchange Service. She is a specialist in modern Germany with an emphasis on transnationalism, decolonization, the North–South divide, and critical race theory. Her publications include *Cold War Germany, the Third World, and the Global Humanitarian Regime* (Cambridge, 2015), and *Welfare, Modernity and the Weimar State, 1919–1933* (Princeton, 1998). She is currently working on a study of human rights and refugee crises in the era of neo-liberalism.

KONRAD J. KUHN is Assistant Professor in the Institute of Cultural Anthropology and European Ethnology at the University of Basel. He was previously Lecturer

in the History Department of the University of Zurich, where he received his Ph.D. in 2010. His research covers the history of knowledge in ethnology; popular memory and cultures of remembrance; and the history of development policy. His publications include 'Liberation Struggle and Humanitarian Aid: International Solidarity Movements and the "Third World" in the 1960s', in Zachary A. Scarlett and Samantha Christensen (eds.), *1968 and the Third World* (New York, 2010); *Fairer Handel und Kalter Krieg: Selbstwahrnehmung und Positionierung der Fair-Trade-Bewegung in der Schweiz 1973–1990* (Berne, 2005); *Entwicklungspolitische Solidarität: Die Dritte-Welt-Bewegung in der Schweiz zwischen Kritik und Politik 1975–1992* (Zurich, 2011); and co-edited with Béatrice Ziegler, *Der vergessene Krieg: Spuren und Traditionen zur Schweiz im Ersten Weltkrieg* (Baden, 2014).

FRANCISCO JAVIER MARTÍNEZ-ANTONIO is FCT researcher at the CIDEHUS, University of Évora, Portugal. He was previously a postdoctoral fellow at SPHERE, University of Paris-Diderot; at the Consejo Superior de Investigaciones Científicas, Madrid; and at the Centre Jacques Berque, Rabat. His research focuses on the history of medicine and public health in the Spanish Empire during the nineteenth and twentieth centuries, with special attention to the Spanish Protectorate in Morocco (1912–56) and the late Spanish Cuba (1878–98). He has published articles in *French History*, *Mélanges de la Casa de Velázquez*, *Dynamis*, *Asclepio*, *Scripta Nova*, *Manguinhos*, and the *Journal of the International Society for the History of Islamic Medicine*. Among his books are *Intimidades de Marruecos: miradas y reflexiones de médicos españoles sobre la realidad marroquí a finales del siglo XIX* (Madrid, 2009); and *Regenerar España y Marruecos: ciencia y educación en las relaciones hispano-marroquíes a finales del siglo XIX* (Madrid, 2011).

DANIEL ROGER MAUL is Associate Professor of Contemporary History at the University of Oslo. After receiving his Ph.D. from the University of Munich in 2005, he was a Lecturer at the University of Giessen and Assistant Professor at Aarhus University. His research interests are the history of international organizations and the emergence of international relief regimes. His publications include *Human Rights, Development and Decolonization: The International Labour Organization (ILO) 1940–1970* (Basingstoke, 2012).

DANIEL PALMIERI is Historical Research Officer at the International Committee of the Red Cross (ICRC). He has published widely on the history of the ICRC and of war, including 'Une neutralité sous influence? Le CICR, Franco et les victimes', *Revue Suisse d'Histoire*, 59/3 (2009); with Irène Herrmann, 'Humanitarianism and Massacres: The Example of the International Committee of the Red Cross', in Jacques Semelin, Claire Andrieu, and Sarah Gensburger (eds.), *Resisting Genocides: The Multiple Forms of Rescue* (New York, 2011); and is co-editor of *Viols en temps de guerre* (Paris, 2011).

JOHANNES PAULMANN is Director of the Leibniz Institute of European History and Professor of Modern History at the University of Mainz. He gained his Ph.D. in 1991 and his *Habilitation* in 1999 at the University of Munich. He has held positions in Munich, at the International University in Bremen, and at the University of Mannheim. He was a Visiting Fellow at Emory University, the London School of Economics, the German Historical Institute London, and at Magdalen College and St Antony's College, Oxford. His research interests include modern European and international history, on which he has published several books and articles. He is co-editor, with Martin H. Geyer, of *The Mechanics of Internationalism: Culture, Society and Politics from the 1840s to the First World War* (Oxford, 2001); and with Fabian Klose he co-edits the blog *Humanitarianism & Human Rights* (<http://hhr.hypotheses.org/>).

CAROLINE REEVES is a Research Associate at the Fairbank Center for Chinese Studies at Harvard University. She received her Ph.D. in History and East Asian Languages at Harvard in 1998. She has taught at Harvard, Williams College, Emmanuel College, and Semester at Sea. Her research focuses on Chinese philanthropy and humanitarianism; the history of the Chinese Red Cross; and dead bodies. Her recent publications include 'The Modern Woman as Global Exemplar, Part I: Biographies of Women Worthies' and 'Part II: Florence Nightingale and a Transnational Gendered Minority', *History Compass*, 13 (Apr. 2015); 'Developing the Humanitarian Image in Late Nineteenth- and Early Twentieth-Century China', in Heide Fehrenbach and Davide Rodogno (eds.), *Humanitarian Photography: A History* (New York, 2015); 'The Red Cross Society of China: Past, Present and Future', in China Medical Board (ed.), *Philanthropy for Health in China* (Bloomington, Ind., 2014); and 'Sovereignty and the Chinese Red Cross Society: The Differentiated Practice of International Law in Shandong, 1914–1916', *Journal of the History of International Law*, 13/1 (2011).

DAVIDE RODOGNO has been Professor of History at the Graduate Institute of International Studies at the University of Geneva since 2011 and was appointed Head of the International History Department in 2014. Previously he was a Research Fellow at the London School of Economics and the Institut d'Histoire du Temps Présent in Paris, RCUK Academic Fellow at the University of St Andrews, and SNSF Research Professor. In 2012 the Kofi Annan Foundation mandated him to write a confidential report documenting the experience of the United Nations and League of Arab States Joint Special Envoy for Syria. He researches the history of philanthropic foundations; transnational public health experts; and the World Health Organization's development programmes during the Cold War. He has published a number of books: *Fascism's European Empire: Italian Occupation during the Second World War* (Cambridge, 2006); *Against Massacre: Humanitarian Interventions in the Ottoman*

Empire (1815–1914). The Birth of a Concept and International Practice (Princeton, 2011); and is co-editor, with Heide Fehrenbach, of *Humanitarian Photography: A History* (New York, 2015).

SILVIA SALVATICI has taught Modern History at the University of Milan since 2015. She was granted a Ph.D. in 1996 and has been Research Fellow at the Italian Academy of Columbia University and Fernand Braudel Senior Fellow at the European University Institute in Florence. Her fields of research are individual and collective memories in post-war societies; women refugees in the twentieth century; gender and human rights; European displaced persons in the aftermath of the Second World War; and the history of humanitarianism. Among her publications are 'Lost Homelands and Reconstructed Homes: Gender and Displacement in Post-War Europe', in David Cesarani, Jessica Reinisch, and J. D. Steinert (eds.), *Beyond Camps and Forced Labour* (London, 2011); '"Help the People to Save Themselves": UNRRA Relief Workers and European Displaced Persons', *Journal of Refugee Studies*, 25 (2012); 'Between National and International Mandates: DPs and Refugees in Post-War Italy', *Journal of Contemporary History*, 49 (2014); and *Nel nome degli altri: storia dell'umanitarismo internazionale* (Bologna, 2015).

MATTHIAS SCHULZ is Professor of the History of International Relations at the University of Geneva. He received his Ph.D. in 1995 from the University of Hamburg and his *Habilitation* from the University of Rostock in 2002. From 2001 to 2006 he was DAAD Visiting Associate Professor at Vanderbilt University, where he also directed the Center for European Studies. He was a Visiting Fellow at Peterhouse College, Cambridge, the German Historical Institute in Paris, and the Institute of European History at Mainz. His research is on European integration; transatlantic relations; the history of humanitarian NGOs; and the history of peace and conflict resolution. His publications include *The Strained Alliance: US–European Relations from Nixon to Carter* (Cambridge, Mass., 2010); and *Normen und Praxis: Das Europäische Konzert der Großmächte als Sicherheitsrat, 1815–1860* (Munich, 2009).

SHOBANA SHANKAR is Assistant Professor of History at the State University of New York, Stony Brook. She received her Ph.D. from the University of California Los Angeles, and has worked as a research consultant for UNICEF. Her research interests include West Africa; religious politics; missionary medicine; and the history of international health and development. Her current project examines how religious and cultural missions shaped India's developing relations with West Africa in the era of decolonization. Her publications include 'Medical Missionaries and Modernizing Emirs in Colonial Hausaland: Leprosy Control and Native Authority in the 1930s', *Journal of African History*, 48/1 (2007); *Who Shall Enter Paradise? Christian Origins in*

Muslim Northern Nigeria, c.1890–1975 (Athens, Ohio, 2014); and co-edited with Afe Adogame, *Religion on the Move: New Dynamics of Religious Expansion in a Globalizing World* (Leiden, 2012).

EVA SPIES is Professor of the Study of Religion with special focus on Africa at the University of Bayreuth. She received her Ph.D. in Cultural Anthropology from the University of Mainz, where she was also Assistant Professor before going to Bayreuth. Her interests are Christianity in Africa; religious diversity; public religion; death and personhood; and the connections between development co-operation, moral knowledge, and religion. Her current research project, with the working title 'A Matter of Life and Death? Religious Encounters in Madagascar and the Differentiation of Modernity', focuses on South–South mission and the encounters and mutual perceptions of religious groups in Madagascar. She is the author of *Das Dogma der Partizipation: Interkulturelle Kontakte im Kontext der Entwicklungszusammenarbeit in Niger* (Cologne, 2009); and co-editor, with Thomas Bierschenk, of *50 Years of Independence in Africa*, special themed issue of *Africa Spectrum*, 45/3 (Hamburg, 2010).

MICHAEL VÖSSING is currently employed in corporate communications and public relations. He received his Ph.D. from the University of Mannheim in 2014 for a thesis entitled 'Humanitäre Hilfe und Interessenpolitik: West-deutsches Engagement für Vietnam in den 1960er und 1970er Jahren'. His research was supported by grants from the ZEIT Foundation (Hamburg) and the Leibniz Institute of European History in Mainz. His interests include the history of historiography and humanitarian aid. He is the author, with Gabriele Lingelbach, of 'National Historical Associations', in Ilaria Porciani and Jo Tollebeek (eds.), *Institutions, Networks and Communities of National Historiography: Comparative Approaches* (Basingstoke, 2012).
